# 1. Review & Approval of Minutes from the August 1, 2011 Annual meeting.

a. Legislative Update – Rep. Cale Keable spoke to the members about the status of the legislative items.

- Protection from liabilities should the PRDMD ever take possession of the lake.
  - Passed into law by adding to the Dam Management legislation the following:
  - 45-62-5.1. Immunity from civil liability. Pascoag Reservoir Dam Management District created pursuant to this chapter shall be immune from civil liability for any tort committed upon any lake bed the Pascoag Reservoir Dam Management District may acquire, hold, use or lease pursuant to section 42-62-3.
- Support for legislation to allow lake property owners to be able to put and remove their boats using the state boat ramps.
  - Cale informed us that the rules governing the state boating ramps are part of the DEM regulations and that he was already discussing this matter with the head of DEM. He was optimistic that this could be done.
- Cale and Senator Fogarty are working with Save the Lakes and DEM in order to bring more attention to protection of freshwater bodies. The main focus is on control of invasive species.
