Ordered 8 yards of gravel.	Material will be used to fill the minor sink holes. (\$135)	Jul 2012

2 Highlight of the 3rd Annual Meeting

- In accordance with the Bylaws, the use of a "Flat" fee method to apportion the budget amongst the property owners has continued... (total budget) / (number of properties).
- The total budget amount for FY 2012-2013 is \$15,950 (vs. FY 2011-2012 \$16,100)
- The number of properties is 319 (last yr was 322), resulting in a per property fee of \$50.00, same as last year. At the annual meeting there was a strong consensus that even with diminishing projects, we should hold the fee at \$50 to allow us to build up the capital fund.
- The budget was unanimously approved at the annual meeting.




